PRE-REINSTATEMENT DISCLOSURE

Alice Queen Limited (previously, Callabonna Resources Limited) (the "Company") will be reinstated to official quotation as from 10am AEDT on Monday, 23 November 2015 following the Company's compliance with listing rule 11.1.3 and chapters 1 and 2 of the ASX Listing Rules.

The following information is released as pre-reinstatement disclosure.

- 1. A copy of the Company Prospectus.
- 2. A copy of the Company's Appendix 1A and Information Form and Checklist.
- 3. A statement setting out the capital structure of the Company following completion of the Equity Offer, Vendor Offer and consolidation.

 - 7.2.1. Confirmation of the issue of 110,700,298 fully paid ordinary shares (on a post-consolidation basis) at a deemed issue price of \$0.055 per share issued to the Vendors;
 - 7.3. Confirmation of the consolidation of all of the existing ordinary shares and options of the Company on a 10 for 1 basis.
 - 7.4. That there have been no material subsequent events to alter the Company's statement of financial position as detailed in Section 6 of the Prospectus.
 - 7.5. That there are no legal, regulatory or contractual impediments to the Company undertaking the activities the subject of the commitments disclosed in the Prospectus.
