Secondary Cleansing Notice Confirmation under section 708A of the Corporations Act

Metals of Africa Limited (ASX: MTA) ("the Company") hereby notifies the ASX under section 708A(5)(e) of the Corporations Act 2001 ("the Act") that the Company has today issued 42,994,824 fully paid ordinary shares. Shareholder approval was obtained for the issue of 34,055,153 Tranche 2 Placement shares and 1,277,777 shares to directors in lieu of salary and directors fees on 13 November 2015. A further 7,661,894 shares were issued on the conversion of Convertible Notes pursuant to exception 4 of ASX Listing Rule 7.2.
