



NOTIFICATION OF FINAL ACCEPTANCES

Lucapa Diamond Company Limited (**ASX: LOM**) (“Lucapa” or “the Company”) advises that as at the closing date of its Option Offer (Offer) of 16 November 2015, the Company had received acceptances for 59,251,513 April 2016 Options from eligible applicants under the Offer representing total funds of \$59,251, before costs.

The Option Offer options, exercisable on or before 29 April 2016, have been allotted and holding statements issued to eligible applicants. These options are exercisable at \$0.30 and are expected to be quoted on the ASX on or before 26 November 2015 under the code LOMOB.

Under the terms of the prospectus, the Directors have the right to issue the shortfall of 8,734,607 April 2016 Options at their discretion within three months of the Offer closing date.

Those Directors who were entitled to allocations of April 2016 Options intend to seek shareholder approval for the issue of their respective allocations at a general meeting to be convened in January 2016.

An Appendix 3B reflecting the revised capital structure following the issue of the above securities has been released with this announcement.
