Secures \$10M Managed Services Contract with Horizon Power

- Empired has successfully secured a managed services contract with Horizon Power.
- The managed services contract is for a term of 5 years, structured as an initial 3 year period with a further 2 year option.
- Empired estimates the value of the contract to be approximately \$10M in Revenue over the term.
- Transition and ramp-up services under the contract are now complete and all operational services under the contract are being delivered.
- Under the contract Empired will provide a range of managed services for all of Horizon Power's ICT infrastructure assets across Western Australia. The scope includes management of core infrastructure and networks, front line service desk and service management, security and management of workplace services including tablet and mobile devices.
- In addition to managed services Empired will be required to provide a range of project services for the enhancement and development of Horizon Powers technology environment.
- This contract win follows a recent run of contract win success taking the total value of new strategic contracts secured this calendar year to greater than \$95m.
