## **ISSUE OF ORDINARY SHARES**

Sprintex Limited (ASX Code: SIX) (**Company**) advises that the allotment of shares under its non-renounceable pro rata offer to Eligible Shareholders announced on 12 October 2015 (**Rights Issue**), which closed on 19 November 2015 has been completed.

The share registry has allotted and issued 1,562,753,472 shares to applicants under the Rights Issue (inclusive of shortfall placements placed to date), which raised a total of approximately \$1,562,753 before costs.

The remaining shortfall of 4,035,927 Shortfall Shares can be placed within three months from the 19 November 2015 closing date, i.e. 19 February 2016, as set out in the Prospectus for the Rights Issue.
