## **Results of Annual General Meeting of Shareholders**

Ram Resources Limited announces that each of the seven (7) Ordinary Resolutions in the 2015 Notice of Annual General Meeting were passed by the requisite majority at today's Annual General Meeting.

The Resolutions were passed on a combination of proxy and show of hands, with none being decided by way of a poll.

With respect to the one (1) Special Resolution, being the Additional 10% Placement Capacity, whilst adopted, only 73% of the votes cast were in favour of the resolution, which is insufficient under ASX Listing Rule 7.1A for the resolution to be passed as a special resolution.

As required by section 251AA(2) of the Corporations Act 2001 and ASX Listing Rule 3.13.2 attached is a summary of the poll voting results for each of the Resolutions considered at the Meeting.
