### ISSUE OF RMG LIMITED SECURITIES – SECONDARY TRADING NOTICE - NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 ("Act")

Further to approval by shareholders in general meeting on 24 November 2015, RMG Ltd ("**Company**") issued a total of 7,750,000 fully paid ordinary shares for services rendered to the Company by third parties and includes issues to directors in lieu of fees.

An Appendix 3B is attached to this notice. ("**Securities**").

#### **Secondary Trading Exemption**

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, sale of the Securities noted above will fall within the exemption in section 708A(5) of the Act.

The Company hereby notifies ASX under paragraph 708A(5)(e) of the Act that:

- (a) the Company issued the Securities without disclosure to investors under Part 6D.2 of the Act;
- (b) as at 14 December 2015 the Company has complied with the provisions of Chapter 2M of the Act as they apply to the Company, and section 674 of the Act; and

    - B. the rights and liabilities attaching to the Securities.
