# NEWZULU SIGNS CONTENT PARTNER AGREEMENT WITH ASSOCIATED PRESS

Newzulu Limited (ASX: **NWZ**, **Newzulu**) is pleased to announce that it has entered into a video content licensing agreement with AP Video Hub, the online video delivery platform of The Associated Press (**AP**). This agreement represents a significant opportunity for Newzulu contributors, with more than half the world's population viewing content from AP on any given day. The platform now also offers live streaming of news and planned events to both digital publishers and broadcasters.
