Notice under section 708A(5)(e) of the Corporations Act

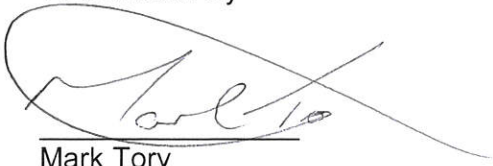
