Closure of Share Purchase Plan Offer

On 18 November 2015, Norwood Systems Limited (ASX:NOR) (“Norwood” or the “Company”) announced it intended to raise \$1.5 million through a Share Purchase Plan (“SPP”) Offer to all eligible shareholders at 8 cents per share, being the same terms offered through a Placement to institutional and sophisticated investors which raised \$5.6 million.

The funds raised from the Placement and the SPP Offer will be applied to the continued marketing of the Company’s World Phone and CORONA products, as well as for ongoing development of these platforms.

Norwood is pleased to confirm that the Company has received SPP applications for approximately \$9.4 million, reflecting the strong support from its shareholders.

All SPP applications will be scaled back on a pro rata basis, to provide a total of \$1.5 million to be raised under the SPP Offer, based on each application amount as provided for in the SPP Prospectus dated 24 November 2015.

Following the scale back to the SPP Offer, applicants can expect to receive the following shares based on their application amounts:-

**The allotment of SPP shares, for a total of 18,750,000 shares to raise \$1.5 million, is subject to shareholder approval at a general meeting of shareholders, being held on 29 December 2015. If shareholders approve the issue of SPP shares then the SPP shares will be issued to applicants immediately following the meeting. If shareholders reject the issue of the SPP shares then the application monies will be refunded.*

All refund monies will be returned to applicants by way of posted cheque in the coming days.
