**ISSUE OF EMU NL SHARES – SECONDARY TRADING NOTICE NOTIFICATION
PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS ACT 2001 (Act)**

On 6 January 2016, Emu NL (**Company**) issued 328,515 fully paid ordinary shares upon payment of the outstanding call of \$0.03 per share on 328,515 partly paid shares (**Securities**).
