On 7 October 2015, Atlantic Ltd (**Atlantic**) entered into a further forbearance agreement with its largest shareholder and major creditor Droxford International Limited (**Droxford**). Droxford agreed that it would forbear and not take any action, until 6 April 2016, to accelerate any of its Convertible Bond or Promissory Note debts that matured in March 2015. Atlantic is now in discussions with Droxford regarding a solvent restructuring of Atlantic's balance sheet.
