### **ASX /MEDIA STATEMENT DIVESTMENT OF COVS TO GPC ASIA PACIFIC**

18<sup>th</sup> February 2016

Automotive Holdings Group (ASX: AHG) has agreed to enter into a revised transaction with GPC Asia Pacific where AHG will sell 21 of the 25 Cows stores to GPC Asia Pacific (GPC).

AHG and GPC announced in July they had reached agreement on the sale of all 25 stores in the Cows network.

The ACCC raised concerns in December 2015 over the likely effect on competition in certain regional areas as a result of the original transaction and the parties have therefore agreed to the revised transaction. The revised transaction is intended to address the ACCC's competition concerns in those regional areas.

Four Cows regional stores (Albany, Esperance, Karratha and Port Hedland) will be excluded from the revised transaction and AHG will retain those stores and operate them through AMCAP. AHG will rebrand the four retained Cows stores [Skipper Transport Parts] to avoid confusion with the Cows stores to be operated by GPC Asia Pacific.

By retaining these stores, AMCAP sees significant opportunities to expand its operations in areas where it already has a presence while maintaining the existing automotive parts operations and activities to ensure no disruption of supply to local customers. AHG has given the ACCC a commitment in the form of a section 87B undertaking to retain and operate these stores for a minimum period of two years from when the revised transaction with GPC is completed.

The transaction is expected to complete in early March.

AHG acquired Cows Parts from the Coventry Group in 2011. The Company restructured the business and has retained the exclusive distribution of Ford and Holden OEM parts in Western Australia within its AMCAP division.

"We believe it is an exciting outcome for both AHG and GPC," said AHG managing director Bronte Howson.

John Moller, Managing Director of GPC Asia Pacific said, "This is a strategic investment for GPC Asia Pacific which is complementary to our existing business. In addition to acquiring the dedicated trade customer focussed automotive parts and accessories Cows business in Western Australia, the acquisition enables the group to enhance our existing offer to Mining and Industrial Customers."
