Operating Results

The consolidated net loss from continuing operations after income tax for JV Global and its subsidiaries ("the Group" or "the consolidated entity") for the half year ended 31 December 2015 was \$104,484 (31 December 2014: (\$136,590)).

Review of Operations

During the December quarter the company booked the anticipated sale of the first half of its joint venture project as announced in previous releases for \$705,000. The second half of the joint venture remains on the market and although a number of offers were received, none met the board's requirements, but offers continue to be received for consideration.

The reduction of debt achieved through the sale restores a higher level of balance sheet flexibility however the company's ability to enter multiple and/or large sized projects, its preferred strategy, remains hindered by its working capital position. It's for this reason the company is considering raising sufficient funds required to adopt its preferred strategy which is expected to generate greater profits, and therefore have a meaningful impact on the company's share price.

The company has been in discussions with potential partners and large developers in line with the company's preferred strategy and have also had inconclusive discussions in regards to large other non related business opportunities. If any further progress eventuates we will advise the market after discussions with the ASX.

The Company's current business model is based on funding the activities to the completion of each project and does, nevertheless, suffer from lack of consistent cash flow on a regular basis. This is acceptable to the Board, considering the above average net profit generated from actual capital employed, year on year. The Company would like to raise additional capital; however it would like to raise this at a realistic price, and in more positive market conditions. The return on capital employed, and to that of the investor, is well within the Company's guidelines.

In the meantime the board together with the major shareholders, investors and the bank continue to provide ongoing support to the Company to create value, albeit marginal through its current strategy of smaller sized ventures incorporating steel framing construction.

The Board continues to seek out other parties who may want to participate on a joint venture basis with the Company on specific projects being offered on a profit sharing basis, with JVG earning project management fees, whilst pursuing other projects in its own right.

JV Global Ltd continues to be one of the least expensive run companies on the ASX, with minimal directors' fees, and the internal administration of the company costing less than \$70,000 per annum.

This austerity will continue until the Directors and management are able to be adequately rewarded for their time, and for the ever increasing liabilities, and responsibilities, attached to being directors of a public company imposed by Politicians, ASX and the ASIC.

The Board will continue to have discussions, communications, assess and look for other possible opportunities, and or diversification of activities as outlined herein as they arise, that could add value to the share price, providing they can be pursued within the ASX listing rules, and fit the Company's reward to risk ratio requirements.

NOTES TO THE FINANCIAL STATEMENTS FOR THE HALF YEAR ENDED 31 DECEMBER 2015

Note 1: Statement of Significant Accounting Policies

Basis of Preparation

This general purpose financial report for the interim half-year reporting period ended 31 December 2015 has been prepared in accordance with Accounting Standard AASB 134 Interim Financial Reporting and the Corporations Act 2001.

This interim financial report does not include all the notes of the type normally included in an annual financial report. Accordingly, this report is to be read in conjunction with the annual report for the year ended 30 June 2015 and any public announcements made by JV Global Limited during the interim period in accordance with the continuous disclosure requirements of the *Corporations Act* 2001.

The accounting policies adopted are consistent with those of the previous financial year and corresponding interim reporting period.

Adoption of new and revised Accounting Standards

In the half-year ended 31 December 2015, the Group has reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to its operations and effective for annual reporting periods beginning on or after 1 July 2015.

It has been determined by the Group that there is no impact, material or otherwise, of the new and revised Standards and Interpretations on its business and, therefore, no change is necessary to Group accounting policies.

Accounting Policies

Revenue recognition

Dividends received from a subsidiary, joint venture or associate shall be recognised as dividend revenue in the profit or loss irrespective of whether such dividends may have been paid out of pre-acquisition profits. Previously, such dividends were treated as a return of capital invested. Such dividends may be an indicator of impairment where the carrying amount of the investment exceeds the consolidated net assets relating to that investment or where the dividend exceeds the total comprehensive income of the respective investee in the period the dividend is declared.

Impairment

At each reporting date, the Group assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the Statement of Comprehensive Income.

Goodwill

Goodwill and goodwill on consolidation are initially recorded at the amount by which the purchase price for a business combination exceeds the fair value attributed to the interest in the net fair value of identifiable assets, liabilities and contingent liabilities at date of acquisition. Goodwill on acquisitions of subsidiaries is included in intangible assets. Goodwill on acquisition of associates is included in investments in associates. Goodwill is tested annually for impairment and carried at cost less accumulated impairment losses. Gains and losses on the disposal of an entity include the carrying amount of goodwill relating to the entity sold.

Going concern

The group has reported an operating loss for the half-year of \$104,484 (31 December 2014: \$136,590). The directors have instituted measures to preserve cash and successfully secured additional finance from external parties to fund current projects. The directors consider the going concern assumption appropriate for the following reasons:

- · There is pre emptive support from major shareholders for a capital raising program; and
- The Board continues to receive approaches from numerous parties with ventures within and outside of the
 existing business sector seeking to either merge or become involved with the parent company.

The directors have concluded that the combination of these circumstances represent a material uncertainty that casts doubt upon the Consolidated Entity's ability to continue as a going concern and whether it will realise its assets and extinguish its liabilities in the normal course of business and at the amounts stated in the financial report.

The directors continued to seek opportunities for the Group and the Board the directors have a reasonable expectation that the group and the company have adequate resources to continue in operational existence for the foreseeable future. For these reasons, they continue to adopt the going concern basis in preparing the interim report and accounts.

Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the interim financial statements based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Group.
