Holding Deed of Company Arrangement ('Holding DOCA')

We advise that creditors were asked to make a decision regarding the future of the Company at the second meeting of creditors of the Company held on 29 February 2016. At this meeting, creditors resolved in favour of the Company executing a Holding DOCA. The purpose of the Holding DOCA is to provide the Administrators with additional time to:

- Conduct further investigations into the Company's business, property & affairs to form an opinion on the likely outcome to creditors in the event of the winding up of the Company; and
- 2. Explore the possibility of a restructure and recapitalisation of the Company with a view to obtaining an improved outcome to creditors compared to the immediate winding up of the Company.

The Holding DOCA must be executed within 15 business days following the date of the meeting. We will provide shareholders with confirmation by way of an ASX announcement following its execution.

Financial Reporting Relief

We advise that the Company has relied on deferral relief under the ASIC Corporations (Externally-Administered Bodies) Instrument 2015/251 ('the Instrument') which provides relief in respect of the Company's obligation to prepare, lodge and have audited its half-year financial report and directors' report in respect of the period ending 31 December 2015 for a period of up to six months from the date of the Administrators' appointment.
