PLACEMENT OF OVERSUBSCRIPTION

26 June 2014

Further to its announcement on 23 June 2014 in relation to the oversubscription of its recently completed entitlement offer, Buderim Ginger Limited (**Company**) is pleased to announce the completion of a placement of 2,065,702 fully paid ordinary shares, at the entitlement offer price of \$0.50, to raise approximately \$1.03 million (before costs).

The shares were placed with existing large shareholders who are also sophisticated investors. The Company's Chief Financial Officer also participated in the placement and now has a relevant interest in 504,753 shares in accordance with his stated intention in the entitlement offer booklet. An Appendix 3B in relation to the placement is attached.

The placement brings the total equity raised by the Company to approximately \$11.36 million before offer costs.

The funds raised recapitalises the Company, substantially strengthens its balance sheet and provides a solid financial platform for ongoing business improvements.

The Board would like to thank all shareholders for their strong support.
