This SPDS supplements the Product Disclosure Statement dated 2 February 2009 ("PDS") and together they set out the terms of issue of the SSR Series of UBS Rolling Self Funding Instalments ("UBS Rolling Self Funding Instalment" or "UBS RSFIs") issued by UBS AG, Australia Branch. This SPDS is to be read together with the PDS and the Supplementary Product Disclosure Statements dated 21 April 2013, 6 December 2011 and 15 February 2011. Words defined in the PDS and the Supplementary Product Disclosure Statements have the same meaning in this SPDS.

ANNUAL INTEREST DATE AND NEW AMOUNTS

In accordance with the PDS, the Interest Amount due on the Annual Interest Date of 27 June 2014, will be automatically added to the Loan Amount for each UBS Rolling Self Funding Instalment.

UBS Rolling Self Funding Instalments will commence trading with the new amounts specified below on 30 June 2014.
