360 CAPITAL GROUP (TGP) UNCONDITIONAL DISPOSAL OF GOULBURN PROPERTY, HURSTVILLE LEASING UPDATE AND \$5 MILLION DEBT REDUCTION

360 Capital Group (ASX code: TGP) ("Group") is pleased to announce the conditional contract to sell the Group's non-core property at 158 Hume Street, Goulburn, NSW for \$4.3 million announced on 24th December 2013 is now unconditional and is in line with book value.

Settlement of the transaction is expected to occur on 13 August 2014 with net sale proceeds to be used to reduce Group borrowings further.

Furthermore, the Group has a number of leasing proposals issued on the Group's Hurstville asset as a result of the ATO lease expiring in February 2015. The Group is currently investigating its various disposal options for this asset, one of which may include a disposal into a 360 Capital managed fund, subject to the various approvals required.

The sale of the Goulburn facility and eventual disposal of the Hurstville property are in line with the Group's stated strategy of becoming a pure real estate fund manager and co-investor with proceeds from the direct asset sales to be recycled into funds management activities.

The Group has today also used surplus cashflow to reduce its drawn debt by \$5.0 million to \$20.0 million.
