Grant of Share Performance Rights to Selected Employees

GBST Holdings Limited (ASX: GBT) hereby advises that it has issued 345,005 performance rights to employees. The rights were issued under the GBST Performance Rights and Option Plan approved by GBST shareholders at the 2012 AGM. Following this grant the total number of share performance rights issued will be 2,177,388.

The Board of GBST also intends to issue 100,486 performance rights to Mr Stephen Lake, Managing Director, on the same terms as the issue of the above performance rights. The issue to Mr Lake will be subject to shareholder approval at the upcoming AGM later this year.
