### Converting Loan Completed

Jatenergy's board of directors are pleased to announce that a converting loan agreement for \$200,000 has been signed with Mr Zhou Xuan Feng and the funds have been deposited.

Jatenergy Development Pty Ltd has been marketing our company in China and has secured this successful introduction to Mr Zhou. This is Mr Zhou's first investment into Jatenergy and if the loan was converted it would represent 8.46% of the issued capital of Jatenergy.

Mr Zhou currently manufactures LED lighting products in China through his company Nanyang City Ling Feng Electronic Technology Co. Ltd. Mr Zhou is enthusiastic about the relationship and said, "I am looking forward to working with Jatenergy as there is potential for strong synergies in relation to building market presence in China, in the near future".

The converting loan agreement provides a \$200,000 borrowing facility for Jatenergy. It can be converted into shares at the discretion of Jatenergy's directors and approval by Jatenergy shareholders at the AGM. The value of conversion is 2 cents a share, in line with current share price, and attracts an interest rate 5% per annum. The board will use the funds for general working capital including office and administrative costs for the company.
