360 Capital Investment Management Limited as responsible entity of the 360 Capital Industrial Fund (Fund or ASX code: "TIX") is pleased to announce Members overwhelmingly approved the Resolutions put to today's Meeting.

Attached is Boardroom Pty Limited's disclosure in respect of the results of voting on the Resolutions.

In summary, Members approved the following two resolutions:

- Resolution 1. Ratification of the placement of units to institutional investors in July 2014
   The Fund's placement capacity has been refreshed providing funding flexibility with which the Fund can best implement its strategy to grow Members returns.
- Resolution 2. Amendments to the Constitution of the Fund
   The approved amendments to the Constitution will provide greater flexibility in which the Fund may raise and price new capital in order to take advantage of attractive investment opportunities and avoid the Fund having to incur certain unnecessary administrative costs.

The Supplemental Deed and amended Fund Constitution will now be lodged with ASIC and the ASX.

360 Capital Industrial Fund is an ASX-listed Fund focused on passive rent collecting from warehouse and logistics properties in Australia in the \$10.0 million plus range. The Fund has strong, defensive, income-focused investment fundamentals via a diversified \$462.1 million portfolio of eighteen quality assets, a weighted average lease expiry of 6.1 years, occupancy of 96.7%, appropriate gearing of 44.7%, distributions tax deferred at approximately 40% to 50% and a forecast FY15 distribution of 19.20cpu. The Fund is externally managed by 360 Capital Group, a leading ASX-listed real estate investor and fund manager that operates under a transparent fee structure and is the largest unitholder in the Fund to ensure ongoing alignment of interests with Unitholders.

360 Capital Group is an ASX-listed, property investment and funds management group concentrating on strategic investment and active investment management of property assets.
