## **Shareholder Update**

Thank you for your continued support of Sandon Capital Investments Limited (Sandon Capital or the Company). I would like to provide you with a brief overview of the investment performance of the portfolio, our inaugural full year results and draw your attention to the Dividend Reinvestment Plan that will apply to the recently declared fully franked 2.0 cents per share special dividend.

#### **Positive Investment Performance**

Since the Company began investing on 19 December 2013, the gross investment return for the Company to 30 June 2014 was 3.70% and the net investment return was 3.01%. During that time, the average cash weighting of the Company's portfolio was 63%, as the Company's capital was carefully deployed into market opportunities.

# **FY2014 Financial Results Highlights**

The Company reported its first full year results since listing in December 2013. The net profit after tax was \$299,108.

The Directors were pleased to declare an inaugural fully franked special dividend of 2.0 cents per share.

## Dividend Reinvestment Plan - 2.0% discount

The Dividend Reinvestment Plan (DRP) will apply to this dividend. The DRP will enable eligible shareholders to reinvest all or part of their future dividends in the form of Sandon Capital shares in a convenient and cost-effective way. No brokerage or other transaction costs are payable on the issue or transfer of DRP shares.
