

Aurora Dividend Income Trust

Performance Report - August 2014

Summary

- The Trust declined by 0.6% in August while the market rose by 0.9%.
- On a risk adjusted basis the Trust under performed by 1.2%, reversing the outperformance of the previous month.
- The under performance of material stocks including BHP and Fortescue impaired performance.

Objective

The objective of the Trust, relative to the Australian equity market, is to provide investors with:

- greater total returns over rolling 5 year periods;
- more income and franking credits each year; and
- less volatility.

The Australian equity market is measured by the S&P/ASX 200 Accumulation Index adjusted to include franking credits.

* The Benchmark is calculated as 50% of the return on the S&P/ASX 200 Accumulation Index adjusted to include franking credits plus 50% of the return on the UBS Australia Bank Bill Index. The weights in the benchmark are the same as the target weights of the Trust.

Distributions

The Trust distributes at least 0.5% of net assets in cash per month. In addition, the Trust distributes franking credits monthly.

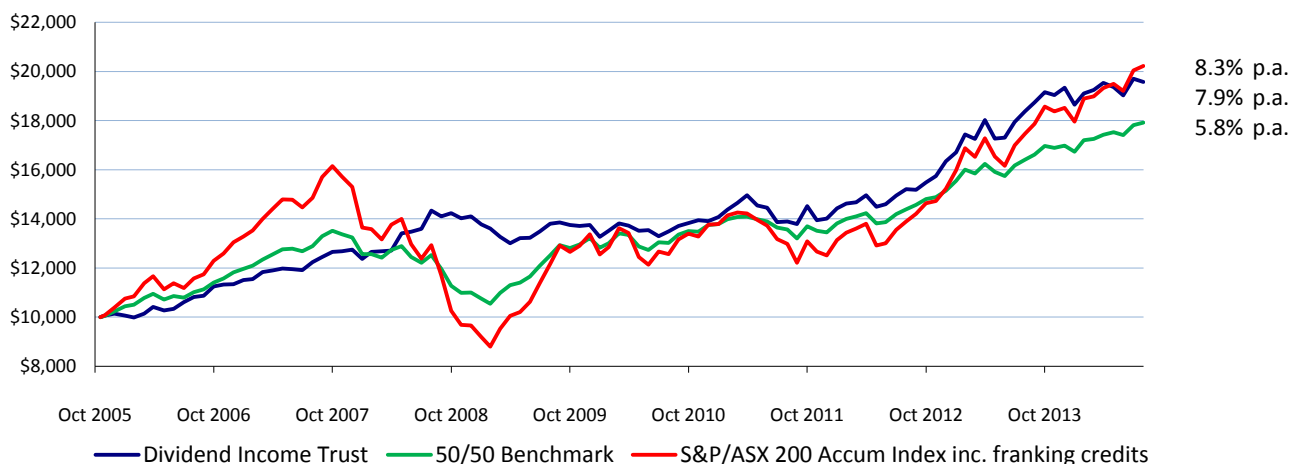

Volatility

Volatility is a measure of risk. The volatility of the Trust is expected to be less than the volatility of the market.

Commentary

Over the month European and US markets seemed to take heart from stronger US economic data, continuing their upward trends (FTSE +1.3%, DAX +0.7%, S&P 500 +3.8%, Dow +3.2%) and closing at or near all-time highs. Asian markets seemed more concerned about data showing a slowing Chinese economy (Nikkei -1.3%, Hang Seng -0.1%, Straits Times -1.4%). The S&P/ASX 200 Accumulation Index came through the reporting season somewhat in the middle ground, at +0.9%, as investors benefited from a swag of dividend payments.

The concerns about the Chinese economy continued the recent trend of volatility in our mining companies with underperformance this month. This detracted from the Trust's performance while the uplift in dividends and franking credits aided performance.

The Trust fell by 0.6% in August, underperforming the broader market. With the equity market rising strongly in recent times and the low cash rate, the Trust is expected to underperform the given 50% of the equity market exposure is hedged.

Since inception, the Trust has returned 7.9% p.a. which is in line with the underlying market, and has achieved this with materially less risk as highlighted in the chart on the previous page.

Consequently, the Trust is expected to outperform when the market is weak and underperform when the market is strong.
