The weekly estimated unaudited pre tax net asset value before withholding tax on unpaid distributions as at 12 September 2014 was \$1.67* per Unit.

The Fund is a long-term investor and does not intend to dispose of its total portfolio. If estimated tax at 35% on unrealised portfolio gains or losses were recognised, the weekly estimated unaudited post tax net asset value before withholding tax on unpaid distributions as at 12 September would be \$1.59.

On 23 June 2014, the Fund declared a distribution of \$0.05 per Ordinary Unit with a record date of 30 June 2014.

These estimates may not take into account all intra-month accruals, which are incorporated in the monthly NTA updates.
