Issue price of Share Purchase Plan

Minotaur Exploration Ltd (ASX:MEP; the "Company") is pleased to advise that the issue price for shares to be issued under the recently completed Share Purchase Plan (New Shares) is A\$0.143 (14.3 cents) per New Share.

Funds raised under the SPP, which totaled \$3 million, will be issued to accelerate drilling and evaluation programs at Artemis Copper – Gold Prospect Cloncurry and Scotia Nickel Project, Kalgoorlie.

The Company will now undertake the "Additional Placement" that was announced on the 21st October 2014, which will seek to raise up to an additional \$1 million in gross proceeds at a price of A\$0.143 (14.3 cents) per share issued.
