Nanosonics expanding European presence with addition of five new countries to Miele agreement

Nanosonics (ASX:NAN), is pleased to announce expansion of its European presence into the Netherlands, Belgium, Luxembourg, Austria and Italy through an expanded agreement with its German distribution partner Miele Professional.

Nanosonics and Miele have been working closely on the introduction of *trophon*[®] *EPR* in Germany. Recognising the compelling benefits of *trophon EPR* and encouraged by early market feedback, Miele proposed an expansion to the current agreement to include these five new countries where they hold a leadership position in disinfection and sterilisation.

"The requirements for stricter controls and more efficacious solutions for ultrasound probe decontamination are growing in Europe", said Michael Kavanagh, Nanosonics Chief Executive Officer and President. This expanded agreement enables us to enter five new markets where Miele is a leader in medical disinfection and sterilisation. Market development activities will begin shortly in these markets commencing with training of the Miele sales and service force in each of the countries. Miele will also showcase *trophon EPR* at MEDICA, the world's largest medical trade fair in Dusseldorf in November".

"Our experience to date with *trophon EPR* in Germany has been positive and we are excited to be able to introduce the technology into these new countries" said Andreas Barduna, Division Director, Miele Professional International.

Nanosonics recently announced the results of a pivotal clinical trial conducted in Germany which highlighted a threefold higher risk of cross contamination using quaternary ammonium wipes (the current standard practice in much of Europe) versus *trophon EPR*. The outcomes of this study along with other planned market development activities will support the adoption of *trophon EPR* throughout Europe.
