Additional Information Pursuant to ASX Listing Rule 3.10.5A

- i. 3.10.5A (a): The issue of the 61,379,783 Fully Paid Ordinary Shares will result in a dilution to existing shareholders by approximately 19.99%;
- ii. 3.10.5A (b): The Company will issue the fully paid ordinary shares as a placement under ASX Listing Rule 7.1 and 7.1A and not as pro-rata or in addition to a pro-rata issue so to enable the Company to introduce a key Strategic Investor onto the register of the Company. The principal of the Strategic Investor, Mr. Mulacek, has over 34 years' experience in oil and gas exploration and production with extensive hands-on experience in Papua New Guinea - including the discoveries of the world class gas and condensate assets of the Elk, Antelope and Triceratops fields. The funds raised from this placement will go towards the first stage of the Company's equity funding requirements for further exploration.
