Dear Securityholder,

IMPORTANT CHANGES TO FUTURE CASH DIVIDEND PAYMENTS

ALS Limited (ALQ) has decided that all future dividend payments to Australian and New Zealand registered holders will be made via direct credit into a nominated financial institution account.

Direct crediting is a more secure and convenient way for shareholders to receive their dividend payments. The benefits include dividends credited to your account on the payment date as cleared funds, removal of risk associated with loss, fraud and theft of cheques, and cost savings for ALQ which in turn benefit all shareholders.

Direct credit of dividends is consistent with the approach that many other dividend paying ASX-listed companies have taken in recent years.

Accordingly, effective from the 2015 interim dividend to shareholders which is likely to be paid in December 2014, dividend payments to ALQ securityholders will be made by direct credit only. No cheque payments will be made to Australian or New Zealand registered holders. Where possible, other overseas registered holders may also be eligible to receive their dividend payments via direct credit in their own currency.

ACTION REQUIRED BY SECURITYHOLDERS

If you currently receive your dividend payments by cheque, you will need to provide your bank account details by completing the enclosed Direct Credit Facility Form and returning it in the reply paid envelope to our share registry, Boardroom Pty Limited.

- you can provide your banking details on-line at www.investorserve.com.au. To use this facility you need to register as a user by selecting the 'register now' button and completing the steps to create an account.

If you do not provide your account details your next dividend payment will be set aside and retained on your behalf in a non-interest bearing bank account until your account details are received by the share registry.

If you already receive your dividend payments by direct credit you do not need to take any further action and this letter is for your information only.

FOR OVERSEAS SECURITYHOLDERS

Please note: If you have not provided your street address, we are unable to pay your Dividend.

In order for our overseas paying authority to comply with the Anti Money Laundering and Counter Terrorism Financing procedures as they apply to them, it is a requirement that, for any payment made to an overseas bank account, the address of the recipient of the payment must be a street address. It cannot be a PO Box.

IBAN: International Bank Account Number.

Sort Code: A 6 digit identifier issued to banks and other institutions in the United Kingdom used to identify specific branches

within a Bank (format is xx-xx-xx).

Suffix No: A 2 digit identifier used by New Zealand banks to identify specific account types.

SWIFT: An 8 or 11 character bank routing ID used by SWIFT members to electronically transmit international wires. An 8

character SWIFT code represents the main branch of a bank and the 11 character SWIFT code represents a

specific branch.
