## **RESULTS OF AGM AND CHANGES OF BOARD AND MANAGEMENT**

Krucible Metals Limited (**Krucible**) (**Company**) (ASX: **KRB**) advises that Messrs Allan Branch, Sean Kelly, Ray Koenig and Andrew Vigar are no longer members of the Board of the Company following recent resignations and resolutions passed by Shareholders at the 2014 Annual General Meeting (**AGM**).

The Company is pleased to announce that, pursuant to the resolution passed at the 2014 Annual General Meeting, Dr Leon Pretorius has been appointed Executive Chairman of the Company. Messrs Dennis Lovell and Josh Puckridge have subsequently also been appointed as Non-Executive Directors of the Company. See attached Appendix A for biographies and terms of the new Board.

As published on the Company's website Allan Branch unilaterally appointed a *caretaking* board following the resignation of all other Directors prior to the AGM. Allan Branch then removed this *caretaking* board prior to requesting nominations for new Non-Executive Directors from Members present. The Board now in place is of the opinion that the initial appointment of these *caretaking* Directors was not valid in the first instance.

The position of Chairman at the AGM was held by Allan Branch, the Managing Director and Chief Executive Officer at the time of the meeting. Mr Branch unilaterally invalidated a number of proxy votes received by the Company. The new Board of Directors has established the Company received legal advice prior to the AGM confirming that there were no grounds for invalidating proxy votes.

The following votes were accepted at the AGM regarding the resolutions contained in the Notice of Meeting dated 30 September 2014 (**NoM**). The following votes were recorded by a poll of voting requested by members present at the meeting:

Resolution 3, adoption of the remuneration report, was carried with a second strike as a result of the in excess of 25% of the votes cast being against the resolution. Resolution 4 was carried though is no longer effective given the resignation and removal of Directors subject to the resolution.

Following this change of Board the Company has terminated all executive contracts with Allan Branch, the Company's former Managing Director and Chief Executive Officer. The Company is also moving towards ensuring all commercial relationships with former Directors have ceased.

#### **Dr Leon Pretorius, Executive Chairman**

BSc (Hons) MSc PhD FAusIMM (CP) MAIG PrNatSci

Dr Pretorius is a Geochemist with 43 years' international mineral and mining experience.

He has spent a total of 20 years since 1978 exploring for a variety of minerals in North Queensland for Utah Development Corporation, Queensland Metals, Keela-Wee Exploration, Deep Yellow and Carbine Tungsten.

Corporately, he has also been involved as a public listed company director in Australia and overseas for more than 28 years and most recently in Australia prior to joining Krucible Metals' Board as its Executive Chairman, he was an Executive Director of Paladin Energy until April 2005; Managing Director of Deep Yellow Limited until March 2010; and, Executive Chairman of Carbine Tungsten until July 2013.
