Trading Halt Request

Dear Ms So

In accordance with ASX Listing Rule 17.1, Republic Gold Limited (ASX: RAU) request that ASX grant a trading halt of quotation of its securities, effective immediately with following:

- RAU is holding a General Meeting of Shareholders at 2.00 p.m. Wednesday 19
 November 2014, to consider, amongst other matters, a transaction that will constitute a
 change in the nature and scale of activities pursuant to ASX Listing Rule 11.1 and
 therefore will be required to re-comply with Chapters 1 & 2 of ASX Listing Rules;
- 2. RAU expects the trading halt to be applied until the outcome of the meeting is known;
- 3. If the resolutions to complete the Proposed Transactions are passed, the Company will request a suspension of its securities which it expects will be applied until approximately 12 December 2014.
- 4. RAU will, during the suspension, seek to finalise the contemplated transaction and recomply with Chapters 1 & 2 of ASX Listing Rules;
- 5. If the resolutions to complete the Proposed Transactions are not passed, the Trading Halt will be lifted.
- 6. RAU is not aware of any reason why the trading halt should not be granted.
