## Page collation error in small number of Scheme Booklets and correction of information

It has come to the attention of Calliden Group Limited ('Calliden') (ASX:CIX) that a page collation error has occurred in one of the Scheme Booklets sent to shareholders earlier this month. In the affected Scheme Booklet, pages 17 to 32 (inclusive) are missing and pages 33 to 40 (inclusive) have been duplicated, with one set upside down.

Calliden has investigated the matter and understands that no more than 20 Scheme Booklets issued to shareholders may be affected by a similar page collation error. This represents 0.77% of the approximately 2,600 Scheme Booklets printed.

#### Correction of substantial holder information

There is an error in the substantial holder information in the table on page 55 of the Scheme Booklet. Hunter Hall Investment Management Limited was no longer a substantial shareholder in Calliden as at 30 October 2014. As disclosed to the market on 16 April 2014, Hunter Hall Investment Management Limited ceased to be a substantial shareholder in Calliden on 11 April 2014. There should have been no reference to Hunter Hall Investment Management Limited in the substantial holder table.
