Results of 2014 Annual General Meeting of Kimberley Diamonds Ltd

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Kimberley Diamonds Ltd advises the outcome of the resolutions put to shareholders at the 2014 Annual General Meeting and the proxies received in respect of the resolutions put to shareholders in the attached summary.

Each resolution was decided on a poll.

The following resolutions were passed:

- (a) Resolution 1: Adoption of Remuneration Report (passed by 83.76% of votes cast);
- (b) Resolution 2: Ratification and approval of prior issue of shares to Rivonia Pty Limited (passed by 99.25% of votes cast);
- (c) Resolution 3: Ratification and approval of prior issue of shares to Sayona Mining Limited (passed by 87.23% of votes cast);
- (d) Resolution 5: Election of Director Mr Rupert Baring (passed by 69.28% of votes cast); and
- (e) Resolution 6: Removal of Director Dr Mark Yumin Qiu (passed by 68.14% of votes cast).

The following resolutions did not pass:

- (a) Resolution 4: Approval of a 10% Placement Facility (69.11% of votes cast in favour, however, as this is a special resolution, 75% of votes were required to be in favour for this resolution to pass);
- (b) Resolution 7: Removal of Director Mr Alexandre Alexander (32.08 % of votes cast in favour);
- (c) Resolution 8: Removal of Director Mr Rod Sainty (31.81% of votes cast in favour);
- (d) Resolution 9: Removal of Director Mr Noel Halgreen (31.79% of votes cast in favour);
- (e) Resolution 10: Removal of Director Mr Rupert Baring (30.76% of votes cast in favour);
- (f) Resolution 11: Election of Director Mr Hugh Thomas (31.95% of votes cast in favour);
- (g) Resolution 12: Election of Director Mr Rob Thomson (32.09 of votes cast in favour); and
- (h) Resolution 13: Election of Director Mr Dale Rogers (31.72% of votes cast in favour).
