#### Completion of Security Consolidation and Change of Name Update

We are pleased to confirm that the 1:4 consolidation of Trinity Group securities has been completed today. The security consolidation was approved by Members at the Annual General Meeting (AGM) on 27 November 2014.

Your transaction confirmation statement which confirms the number of Trinity Group stapled securities that you held prior to the consolidation and post the consolidation is enclosed.

#### Change of Name

We also confirm that the process for changing the Trinity Group name to Unity Pacific Group is nearly complete. The change of name for each of Trinity's individual entities has now been registered by ASIC.
