ASX Announcement

CAPITAL RAISING

Further to the ASX announcement dated 8 December 2014 wherein the Company announced it will be undertaking a Placement, the Company is pleased to announce the outcome of the Placement has raised \$528,000 to continue the exploration program on the Ansongo Manganese project.

The Company will issue part of the Placement Securities within its existing placement capacity and the balance subject to shareholder approval at an EGM to be held in January 2015.

The placement acceptances are as follows:

1. The company will allot 32.4m shares at 1.3 cents per share in accordance with the Company's placement capacity under Listing Rules 7.1 and 7.1A. The appendix 3B is attached;
2. Shareholder approval will be sought to issue a further 5,110,018 shares at 1.3 cents per share;
3. Shareholder approval will be sought to issue 3,076,923 shares at 1.3 cents to directors who wish to participate in the Placement on the same terms as other shareholders;
4. Shareholder approval will be sought to issue 20,307,692 attaching unlisted options to those parties who participated in the Placement on the basis of 1 option for every 2 shares subscribed for. The options will be exercisable at 3 cents and expire 31 December 2017.
