Orion Metals Limited (ORM) has made application for 3 new tenements (E80/4919, E80/4920, E80/4921) and relinquished one tenement (E80/4596) from its Tanami West Project, and withdrawn from an exploration agreement with J & J Withers in NE Queensland (Refer Table 1).

Relinquished tenement E80/4596 in NE Western Australia is a very large tenement, 113 sub-blocks in total, attracting high administrative costs and exploration expenditure commitments. The ORM Board, while committed to exploring the Tanami region, is looking to prioritize its exploration dollars towards its other better quality, more prospective REE and gold tenements in the area.

The three new tenement applications, all 100% ORM (Rich Resources Investments P/L), compliment the current Orion Metals Limited REE and gold tenement portfolio.

Additionally, the ORM Board has withdrawn from the agreement for exploration access to tenements (EPM 17011, EPM 17891, MLA 30218) held by J.W Withers in NE Queensland. The tenements were included in the Mt Surprise Project, Queensland.
