ISSUE OF PLACEMENT SHARES

Aeris Environmental Ltd (ASX Code: AEI) is pleased to announce that is has raised \$5,005,444 through the issue of 22,752,018 new shares in a placement to a group of professional, sophisticated and other investors to whom disclosure under Part 6D.2 of the Corporations Act is not required. The shares have been issued at an issue price of \$0.22 per share.

The amount raised is to fund the roll-out of the Aeris SmartENERGY platform, and for the further rapid commercialisation and marketing of the Company's AerisGuard product portfolio. Consistent with these objectives new key staff members are being recruited to bring substantial expertise and a strong track record to accelerate Aeris' sales and business development. Aeris outlined to its shareholders its strategic plans and priorities at its recent Annual General Meeting (AGM), and these funds will also enable the Company to conduct further research and development activities, and to provide funds for corporate costs and provide working capital.

The placement was substantially oversubscribed, with a number of leading institutions, including Allan Gray Australia, Regal Funds Management and other local institutions, representing greater than 50% of the placement.

Information on the raising was detailed in the Company's Notice of AGM for the meeting held on 27 November 2014. At the AGM shareholders approved the issue of 17,000,000 shares. The balance of shares issued in this placement is from the Company's normal 15% allowance under ASX Listing Rule 7.1.

Attached is an Appendix 3B for the issue of these shares.
