1. GENERAL

The Company announces that is proposes to make a rights issue pursuant to Section 708AA of the Corporations Act without issuing a product disclosure statement in relation thereto.

2. PARTICULARS OF THE ISSUE

The rights issue is a pro-rata non renounceable entitlement issue for one (1) new share for every four (4) shares held at the Record Date of the 6 January, 2015. The issue price for each new share is \$0.225.

The offer seeks to raise approximately \$4.35 million. The offer is fully underwritten. It will result in the issue of 19,340,741 new shares in the Company.

The purpose of the rights issue is to fund the Company's the company's cash component for the acquisition of Arte Mobile Technology Pte Ltd.
