## **QUARTERLY ACTIVITIES REPORT – PERIOD ENDING 31 DECEMBER 2014**

We are pleased to provide the following report on activities carried out by Outback Metals Limited (OUM) during the quarter ended 31<sup>st</sup> December 2014.

Discussions continued with several parties who had expressed interest in involvement in OUM's existing projects. In addition, several discussions were held with parties interested in ASX listings using OUM's subsidiaries.

Several site visits were undertaken with interested parties, but at the completion of this reporting period there had been no material advancement of discussions with any party.

The company recapitalised its financial obligations in November by entering into a new convertible note (including a financing agreement and other documents that were sent to all shareholders prior to the AGM).

The tenements held by OUM (all 100% owned) in the northern region of the Northern Territory (within about 400 kilometres of Darwin) at the end of the quarter were:-
