

## QUARTERLY ACTIVITIES REPORT THREE MONTHS to 30 SEPTEMBER 2014

Key activities undertaken by the company in the Sep 2014 Quarter included:

- The appointment of Samsung C&T to produce a lump sum Engineering, Procurement and Construction (EPC) contract for development of the Project.
- Discussions with Credit Suisse AG to restructure the Senior Secured Guarantee Facility Agreement (SSGFA), which secures the take or pay obligations of Springsure Creek Coal Pty Ltd to Wiggins Island Coal Export Terminal (WICET) for ship loading capacity and to Aurizon for rail access.
- Negotiations with WICET, its advisors and other shippers to amend the commercial terms of WICET agreements to better match a delayed ramp up profile for the Project.
- Continued work with directly and indirectly affected landowners in relation to land acquisition and/or land compensation arrangements and make good agreements for ground water, resulting in two of the six objections to the mining leases being withdrawn.
- Continuing discussions with a range of parties including, including Credit Suisse, existing and potential new major equity investors to obtain additional equity or debt funding.
- Discussions with parties to progress binding commitments for sale of Bandanna's Interests in either the South Galilee or Dingo West projects.

On 22 September 2014, due to continued deterioration of coal markets, the inability to obtain alternative funding to progress the grant of the mining leases and the inability to reach agreement with Credit Suisse to restructure the SSGFA, the Board of Bandanna Energy Limited resolved to place Bandanna Energy Limited, Bandanna Coal Pty Ltd, Springsure Property Holdings Pty Ltd and Springsure Creek Coal Pty Ltd into voluntary administration appointing Grant Sparks, Martin Ford and Phillip Carter of PPB Advisory as joint and several voluntary administrators.




Figure 1 – Granted Coal Tenements (EPC) and Mining Lease Applications (MLA)
