Bronson Group Limited (ASX: BGR) wishes to announce that it will seek to undertake a placement of its Shares in the Company at an issue price of \$0.01 per share to raise a maximum amount of \$250,000.

Accordingly the attached Appendix 3B relates to the initial placement of 7 million Shares at \$0.01 to raise a total of \$70,000.

The funds will be used for general working capital purposes and the investigation of additional product distribution and marketing opportunities. This placement will be conducted pursuant to the Company's 15% placement capability.
