

Second Prospecting Licence for Isabel Nickel Project

HIGHLIGHTS

- Prospecting Licence granted for San Jorge tenement, located approximately 5km south-west of Axiom's Kolosori tenement on Santa Isabel Island
- Opportunity for parallel development to increase operational efficiencies
- Exploration by International Nickel Company Limited (INCO) in the 1960s-70s indicated potential higher grade mineralisation at depth

Axiom Mining Limited ('Axiom' or 'the Company') is pleased to announce the grant of a Prospecting Licence for the San Jorge tenement of the Isabel Nickel Project, Solomon Islands.

The San Jorge tenement is 36km² and located less than 5km from Axiom's Kolosori tenement on Santa Isabel Island, where the Company has delivered high grade results from its initial drilling program.

Axiom CEO Mr Ryan Mount said, "We are encouraged by the grant of this second Prospecting Licence for the Isabel Nickel Project, which is a strong sign of the Solomon Islands Government's support for our operations."

"This second tenement almost doubles our exploration footprint in the southern Isabel province and further enhances the commercial potential of the project.

"We will investigate opportunities to develop San Jorge in parallel with our first tenement, which will allow for increased economies of scale for our proposed direct shipping of ore (DSO) operation."

Both the San Jorge and Kolosori tenements have been extensively explored by previous explorers and produced historic results indicating strong mineralisation.

A technical review of historical data is underway, with a drill program to commence in the second half of 2015, which will focus on confirming the historical data compiled by INCO and testing the higher grade saprolite mineralisation beneath the limonite zone.

About the Isabel Nickel Project

The Isabel Nickel Project is considered to be one of the largest nickel laterite deposits in the Pacific.

The project has been extensively explored by mining and engineering industry leaders, International Nickel Company Limited (INCO) and Kaiser Engineers International Inc (Kaiser Engineers).

Axiom Mining holds a 50-year registered lease and Prospecting Licence over the Kolosori tenement, and a Prospecting Licence for the San Jorge tenement and is targeting the establishment of a DSO operation by late 2015.
