ITL OPENS STATE OF THE ART MALAYSIAN MANUFACTURING AND PRODUCTION PLANT

ITL Limited ("ITL"), the diversified healthcare Company, announces that one of its divisions, ITL BioMedical ("Company") has successfully opened a brand new state of the art manufacturing and production facility ("facility") in Bemban, Malaysia.

ITL Biomedical provides biological (primarily blood) sampling solutions designed and engineered for human use with a strong focus on safety, reliability and process efficiency.

The facility in Malaysia is a major milestone in ITL's history and development. The production area has doubled to 5,000 sqm on a 10,000 sqm site, and the number of clean rooms has increased from two to three.

The substantially larger facility provides a solution for ITL's expansion needs. The planned transfer of further business from ITL Healthcare Australia is already underway and will mean a large reduction in costs. ITL's Healthcare division assembles procedure and medical packs in Melbourne and distributes to over 200 hospitals in Australia.

The Company's previous manufacturing facilities at Lahat in Malaysia were significantly space constrained. In December 2013 ITL acquired an existing very outdated medical device factory that included clean rooms. The expansion and renovation was completed on schedule and on budget in December 2014, and the official opening was 19 March.

Bill Mobbs, ITL's Executive Chairman commented "This state of the art facility will be a stepping stone towards considerable growth for both the Biomedical and Healthcare divisions.

"The facility will give ITL the ability to cater for our customers increased demands as well as improving quality and efficiency. In 2014 ITL brought six new products to market, and with the new facility we intend to release 14 in 2015."
