## UPDATE - ACQUISITION OF LED LIGHTING COMPANY

### HIGHLIGHTS

- ASX confirms the proposed transaction with Nanyang Ling Feng Electronics Technology Company is a Chinese manufacturer of LED lighting, will constitute a change in the nature and scale of the Company's activities and as such the Company will need to comply with Chapters 1 and 2 of the Listing Rules before it completes the transaction.

On 24 March 2015 Jatenergy Limited ("JAT" or the "Company") announced a proposed transaction with Nanyang Ling Feng Electronic Technology Company. In that announcement, JAT advised that it had applied to the ASX for a determination as to whether the acquisition will constitute a change in the nature and/or scale of the activities of JAT in accordance with Chapter 11 of the ASX Listing Rules.

The Australian Stock Exchange have advised the Company on 2 April 2015 that the Proposed Transaction will constitute a change in the nature and scale of the Company's activities in terms of Listing Rule 11.1 and that the Company will be required under Listing Rule 11.1.3 to comply with all of the requirements of Chapters 1 and 2 of the Listing Rules before it completes the transaction.

Further, the Company advises that the Share Purchase Agreement has not been finalised but it is now likely to be finalised before 13 April 2015. This delay is not believed to cause any delays to the proposed despatch of the Notice of General Meeting on 29 April 2015.
