MARCH 2015 QUARTERLY ACTIVITIES REPORT

Aguia Resources Limited (ASX: AGR) ("Aguia" or "Company") is pleased to report on its activities for the March 2015 Quarter:

Highlights:

- Total JORC compliant Indicated and Inferred resources increased 130%, from 30 Mt to 70.1 Mt (comprised of 15.2Mt Indicated and 54.0Mt Inferred) with an average grading of 4.20% P₂O₅
- Higher grade oxide zone from surface more than doubled, with combined Indicated and Inferred resource of 3.9Mt of $10.25\% P_2O_5$
- Drill program at Três Estradas South was completed and continued to intersect excellent widths and grades of phosphate mineralisation extending the strike length from 1.3km to 2.5 km
- Positive initial results at the Cerro Preto target, showing great continuity along strike at surface with highgrade intercepts from channel sampling which include
 - 55.0 m grading 6.99% P₂O₅ (CH-AM-28)
 - 23.0 m grading 8.61% P₂O₅

Corporate

- The Company raised \$169,902 through a Rights Issue in January and further successfully completed a Shortfall Placement of \$845,900 with an additional \$790,000 through a follow-on share placement in April
- Justin Reid appointed new Executive Chairman and Managing Director and Catherine Stretch appointed Chief Commercial Officer.

Planned for the June Quarter:

- Completion of additional metallurgical test work at SGS facilities in Lakefield, Canada targeted for May 2015
- Scoping Study/PEA by SRK Consulting for the Três Estradas deposit targeted for release July 2015
- Ongoing assessment and development of phosphate Rio Grande assets at Joca Tavares and Cerro Preto





Figure 1: Rio Grande Tenement Map and Key Prospects – Refer to Tenement Register for Licence Details

During the March Quarter, Aguia focused on advancing the development of its Rio Grande phosphate assets which include the Três Estradas and Joca Tavares carbonatite hosted deposits and the Cerro Preto sediment hosted deposit located in the state of Rio Grande do Sul in Southern Brazil (Figure 1).

Três Estradas Deposit

From December 2014 to February 2015, the Company conducted a reverse circulation and diamond drilling programme over Três Estradas South. The program was designed to test the southwest trending strike extension of the previous JORC compliant mineral resource¹ at Três Estradas of 30.5M tonnes at $4.3\% P_2O_5^2$,

which included Indicated resources of 9.9M tonnes @ $5.03\% P_2O_5$ and Inferred resources of 20.6M tonnes @ $3.94\% P_2O_5$, which represented less than half of the mapped strike length of the carbonatite body.

A total of 69 new holes were drilled including 49 reverse circulation holes (1,153 meters) to outline the higher grade oxide zone from surface and another 20 diamond drill holes (3,273 meters) to investigate the primary carbonatite at depth (Figure 2). Drilling continued to intersect excellent widths and grades of phosphate mineralization.


Significant results from the diamond drilling include:

- \circ TED-14-043 with 53.94 meters grading 5.27% P₂O₅, from 17.50 meters,
- o TED-14-041 with 62.65 meters grading 4.32% P₂O₅, from 9.15 meters, and
- \circ TED-14-042 with 74.00 meters grading 4.11% P₂O₅, from 12.00 meters.

Significant results from the reverse circulation drilling to date include:

- o TER-14-107 with 22.00 meters grading 14.07% P₂O₅, from 13.00 meters,
- \circ TER-14-108 with 33.00 meters grading 13.85% P₂O₅, from 5.00 meters,
- o TER-14-111 with 38.00 meters grading 10.74% P₂O₅, from 1.00 meters, and
- o TER-14-110 with 44.00 meters grading 10.07% P₂O₅, from surface.

The program confirmed an additional 1.3 km of mineralized strike-length to the southwest, extending the strike mineralization to 2.5 km. Aguia commissioned leading independent global consulting company SRK to prepare the JORC compliant Mineral Resource Statement upgrade. The mineral resources are reported within a conceptual pit shell at a cut-off grade of $3\% P_2O_5$. The JORC compliant memo including the competent person statement was announced to the market on April 27, 2015.

The updated Mineral Resource Statement of 70.1 Mt grading 4.20% P_2O_5 (15.2Mt Indicated and 54.9Mt Inferred) represents a 130% increase to previous 2013 model that included 30 Mt grading 4.15% % P_2O_5 (Table 1). The higher grade oxide from surface has doubled and now totals 3.9 Mt combined Indicated and Inferred resource grading 10.25% P_2O_5 .

Aguia has engaged SRK Consulting to consolidate the updated mineral resource model and the upcoming beneficiation results, as well as the data from the September, 2014 Mining Study into a Preliminary Economic Assessment (PEA), which is expected to be completed in the next Quarter.

The Company is currently performing additional bench scale flotation tests at SGS Lakefield in Canada to improve the current P_2O_5 process recovery of 60%. Results of this program are expected to be announced in May 2015.


Joca Tavares Deposit

The Joca Tavares project is another carbonatite hosted deposit located 41 kilometres east-south-east from the Três Estradas project. The tenement covering the carbonatite was granted during the June Quarter 2013 and as reported previously the Company carried out a programme of shallow auger drilling to delineate the boundaries of the carbonatite with the results to be used in planning upcoming drilling programmes to develop high-grade optionality for the Três Estradas deposit.

Cerro Preto Deposit


Figure 4: Geological Map of the Arroio Marmeleiro Formation highlighting the location of the Cerro Preto Target

The Company has continued scouting and mapping over the Arroio Marmeleiro Formation (Figure 4), concentrating on the Cerro Preto sediment hosted phosphorite discovery. Work subsequent to that outlined in the December 2014 quarterly report has identified a new bed of black phosphorite that strikes over approximately 4 km. These initial results reinforce the great potential of this target, which has proven great continuity along strike at surface and has returned high-grade intercepts from channel sampling.

To date, three beds of black phosphorite have been mapped in the Cerro Preto target, along strike lengths that vary from about approximately 700m to 5km and with an apparent thickness from 50m to up to 200m (Figures 7). Highly encouraging results were returned from initial systematic rock chip sampling, including assays with grades up to $20.4\% P_2O_5$. Subsequent work, announced to the market on January 23, 2015, sampled another 26 trenches, which provided some very encouraging results including:

- 55.0 meters grading 6.99% P2O5 CH-AM-28,
- 23 meters grading 8.61 P2O5 CH-AM-23

The Cerro Preto target has the potential to develop into a completely new phosphate district as it bears great similarity to the Western Phosphate Field in the US that has been continuously mined for over a century.

Lucena Phosphate Project

The Lucena Phosphate Project, comprised of 49 tenements and applications for 350km^2 , contains an initial JORC compliant Inferred Mineral Resource of 55Mt grading $6.42\%~P_2O_5$ in the state of Paraiba in north eastern Brazil. A feature of the Lucena tenement is outcropping limestone, which is a potential commercialisation opportunity given the presence of a number of cement plants in the region. There was no activity during the March Quarter.

Mata da Corda Phosphate Project

The MCPP is the subject of an Option Agreement executed with Vicenza Mineração e Participações S.A. ("Vicenza") who are the operator and have an option to acquire 70% of the project. It is comprised of 76 tenements and applications for 125 Km² (Figure 9). As announced in the September 2014 Quarterly Report, Vicenza's option was amended on October 15th, 2014 to allow Vicenza to acquire a 100% interest in the Mineral Rights. There was no activity during the March Quarter.

Atlantic Potash Project

During the Quarter the Company continued to review data from historic work to aid in planning future activities on the project. The project is comprised of 17 tenements and applications totalling 273 km², following relinquishment of a number of tenements during the Quarter.

Proceedings (as announced previously) against Aguia's subsidiary Potassio do Atlantico Ltda (PAL) taken out by Prest Performance Services Limitada ("Prest") on 20th June 2013 regarding an alleged breach of a drilling contract are still yet to be heard before the courts.

As noted in the Company's previous announcement, the Company believes that PAL has acted appropriately at all times and is not in breach of the contract and both PAL and the Company will vigorously defend the action. The Company will update the market when further information comes to hand.

Corporate Activities Update

On January 9th, 2015 the Company launched a 1 for 10 non-renounceable rights issue at \$0.04 per new share, having received applications from eligible shareholders for 4,247,574 new shares, for total proceeds of \$169,902.96 (see also announcement of February 4, 2015). On April 7th, 2015 the Shortfall Placement of 21,147,503 new shares at \$0.04 per share was completed, to raise a total of \$845,900. Shortly after this, on April 15th, 2015, the Company announced a Follow-on Share Placement of 19,750,000 new ordinary shares at \$0.04 per share representing an additional capital raising of \$790,000.

On April 7, 2015, the Company announced the appointment of Justin Reid as the new Executive Chairman and Managing Director, replacing David Gower who will move to Independent Director and Prakash Hariharan who has resigned as a Director but will remain as strategic advisor for the Company. In addition Catherine Stretch was appointed as Chief Commercial Officer, focusing on the administration and strategic positioning of the Company as it migrates towards production and evolves into a major supplier to the Brazilian Agribusiness sector.

On March 16th, 2015, the Company confirmed that the existing \$ 1,000,000 Line of Credit funding with Forbes Empreendimentos Minerais Ltda (as announced to the ASX on September 25, 2014) was extended to June 30, 2015. All other terms and conditions of the Line of Credit Agreement remain unchanged.

Plans for the June Quarter

The Company will continue to focus on its flagship Três Estradas phosphate project. The ongoing bench scale flotation tests are targeted for completion in May 2015. These results together with the recent Mineral Resource update and the Conceptual Mining Study, which was announced to the market on September 16th, 2014, will provide the necessary information to conduct a Preliminary Economic Assessment (PEA). SRK Consulting was engaged to conduct the PEA, which is expected to be completed in the next quarter.

The Company will continue to assess the exciting new discovery at Cerro Perto. At the completion of the ongoing surface mapping and sampling, initial drilling is planned to test the thicknesses and grades at depth.

Aguia is a fertiliser company focused on the exploration and development of phosphate and potash projects in Brazil to supply the Brazilian agriculture sector. Brazil is Latin America's biggest economy and is heavily reliant on imports of up to 50 per cent of its phosphate and 90 per cent of its potash needs. Aguia is well positioned to capitalise on the growing demand for phosphorus and potash based fertilisers in the expanding agriculture sector in Brazil and controls three large projects, located close to existing infrastructure. This includes indicated resources of 15.2 Mt @ 5.02% P_2O_5 and inferred resources of 54.862 Mt @ 3.98% P_2O_5 .

The Lucena Phosphate Project has a current JORC compliant inferred mineral resource of 55.1Mt grading 6.42% P_2O_5
