# UXA Exit from Administration and Appendix 3B – Issue of Ordinary Shares

The Directors of UXA Resources Ltd ("UXA" or "the Company") are pleased to confirm that the Company has been released from Administration.

Following effectuation of the Deed of Company Arrangement on 5 May 2015 the Deed Administrator has retired and the Directors have resumed control of the Company. The Directors thank the Deed Administrator for his assistance during the period the Company was in Administration.

UXA also announces that it has placed 2,760,000 ordinary shares for \$138,000 of equity from new investors. The placements were made under the Company's existing 15% capacity, and shareholder approval will therefore not be sought. The relevant Appendix 3B is attached.

The Nabarlek North property is highly prospective for unconformity-style uranium deposits, and an aggressive exploration program is proposed for 2015.
