### **DIRECTION TO CHESS DEPOSITARY NOMINEES PTY LTD**

Each CHESS Depositary Interest ("CDI") is evidence of an indirect ownership in the Company's shares of ordinary share ("Shares"). Each CDI is equivalent to one Share of the Company so that every one (1) CDI that you own as at **4:30pm (Sydney, Australia time), 2:30pm (Hong Kong time) on Friday, 29 May 2015,** entitles you to one (1) vote. The underlying Shares are registered in the name of CHESS Depositary Nominees Pty Ltd ("CDN"). As holders of CDIs are not the legal owners of the Shares, CDN is entitled to vote at the Annual General Meeting of Security holders on the instruction of the registered holders of the CDIs.
