NOTICE OF MEETING

Notice is hereby given that the Annual General Meeting of Etherstack plc (the "Company") will be held at 10.00 am (London time) on Friday 19th June 2015 at the office of Cavendish Ware Limited, Becket House, 8th Floor 36-37 Old Jewry, London, to consider and, if thought fit, pass the following resolutions:

The Explanatory Statement that accompanies and forms part of this Notice of Meeting describes the matters to be considered.

AS ORDINARY RESOLUTIONS

- 1. To receive and adopt the accounts of the Company for the year ended 31 December 2014 and the Directors' and Auditors' reports thereon.
- 2. To re-appoint Grant Thornton UK LLP as auditors to hold office until the conclusion of the next annual general meeting at which accounts are laid before the Company and to authorise the Directors to fix their remuneration.
- 3. In substitution for any existing authorisation under section 551 of the Companies Act 2006 but without prejudice to the exercise of any such authorisation prior to the date of this resolution, the Directors of the Company are generally and unconditionally authorised in accordance with that section to allot shares in the Company and to grant rights ("relevant rights") to subscribe for, or to convert any security into, shares in the Company up to an aggregate nominal amount of £31,980 such authorisation to expire at midnight on 19 June 2016 or, if earlier, at the conclusion of the next Annual General Meeting of the Company, unless previously renewed, revoked or varied by the Company in general meeting, save that the Company may at any time before the expiry of this authorisation make an offer or agreement which would or might require shares to be allotted or relevant rights to be granted after the expiry of this authorisation and the Directors of the Company may allot shares or grant relevant rights in pursuance of any such offer or agreement as if the authorisation conferred hereby had not expired.
- 4. Approval for the issue of up to 1,350,000 fully paid ordinary shares

THAT, for the purposes of Listing Rule 7.1, and for all other purposes, approval be given for the issue and allotment by the Company of up to 1,350,000 fully paid ordinary shares, upon conversion of the convertible notes which were issued in July 2014 totalling AUD\$540,000 which may be converted into 1,350,000 fully paid ordinary shares at AUD\$0.40 for each fully paid ordinary share and in accordance with the other conditions of their issue.

5. Approval for the issue of up to 450,000 fully paid ordinary shares to Mr Paul Barnes

THAT, for the purposes of Listing Rule 10.11, and for all other purposes, approval be given for the issue and allotment by the Company of up to 450,000 fully paid ordinary shares to Mr Paul Barnes, upon conversion of the convertible notes which were issued in July 2014 totalling GBP 100,000 which may be converted into 450,000 fully paid ordinary shares at AUD\$0.40 for each fully paid ordinary share and in accordance with the other conditions of their issue.

6. Approval for the issue of up to 450,000 fully paid ordinary shares to Mr Peter Stephens

THAT, for the purposes of Listing Rule 10.11, and for all other purposes, approval be given for the issue and allotment by the Company of up to 450,000 fully paid ordinary shares to Mr Peter Stephens, upon conversion of the convertible notes which were issued in July 2014 totalling AUD\$180,000 which may be converted into 450,000 fully paid ordinary shares at AUD\$0.40 for each fully paid ordinary share and in accordance with the other conditions of their issue.



AS SPECIAL RESOLUTIONS

- 7. THAT subject to the passing of resolution numbered 3 above ("Section 551 Resolution") and in substitution for any existing power under sections 570 and 573 of the Companies Act 2006 (the "Act") but without prejudice to the exercise of any such power prior to the date of this resolution, the Directors of the Company are empowered in accordance with those sections to allot equity securities (within the meaning of section 560 (1), (2) and (3) of the Act) either pursuant to the Section 551 Resolution or by way of a sale of treasury shares, in each case as if section 561(1) of the Act did not apply to such allotment, provided that this power shall be limited to:
 - (a) the allotment of equity securities (otherwise than pursuant to sub-paragraph (b) below) up to an aggregate nominal amount of £12,792; and
 - (b) the allotment of equity securities in connection with an offer to all holders of ordinary shares of 0.4p each in the capital of the Company ("Ordinary Shares") in proportion (as nearly as may be) to the respective numbers of Ordinary Shares held by them (but subject to such exclusions, limits or restrictions or other arrangements as the Directors of the Company may consider necessary or appropriate to deal with treasury shares, fractional entitlements, record dates or legal, regulatory or practical problems in or under the laws of any territory, or the requirements of any regulatory body or any stock exchange in any territory or otherwise howsoever); and such power shall expire when the Section 551 Resolution is revoked or would (if not renewed) expire, but so that this power shall enable the Company to make an offer or agreement before such expiry which would or might require equity securities to be allotted after such expiry and the Directors of the Company may allot equity securities in pursuance of any such offer or agreement as if such expiry had not occurred.

 - (a) the maximum number of Ordinary Shares authorised to be purchased is 3,198,078 (representing 10 per cent of the Company's issued ordinary share capital):

Explanatory notes to the resolutions

Resolution 1: Receive the 2014 Annual report

The Directors are required by company law to present the 2014 Annual report comprising the 2014 financial statements, the Directors report and the Auditors report on the financial statements to the meeting. These can be viewed on the Etherstack website:

Resolution 2: Re-appointment and remuneration of Auditors

The Company is required at each general meeting at which financial statements are laid, to appoint auditors who will remain in office until the next general meeting at which financial statements are laid.

Grant Thornton UK LLP has expressed willingness to continue in office. In accordance with company law and good corporate governance practice, Shareholders are asked to authorise the Audit & Risk Committee to determine the auditors' remuneration.

Resolution 3: Authority to allot shares

This resolution asks Shareholders to renew the Directors' authority to allot new shares. The authority, if approved, will expire on the later of 19 June 2016 and the date of the 2016 annual general meeting. The authority will allow the Directors generally to allot new shares, and grant rights to subscribe for, or convert other securities into shares up to a nominal value of £31,980 which is, in accordance with good corporate governance practice, equivalent to approximately 25 per cent of the total issued ordinary share capital of the Company. The Directors consider it desirable, however, to have the maximum flexibility permitted by corporate governance guidelines to respond to market developments and to enable allotments to take place to finance business opportunities as they arise.

Resolution 4: Approval for the issue of up to 1,350,000 fully paid ordinary shares

In July 2014, the Company issued AUD \$540,000 Convertible Notes to professional and sophisticated investors including the issue of AUD\$360,000 to Directors of the company as set out in the explanatory notes to Resolutions 5 and 6. This Convertible Note issue was outlined in the Half Year report reported to the ASX on 29 August 2014. The proceeds of issue of Convertible Notes were used to increase working capital. Subject to the approval at the AGM, the Convertible Notes are convertible into 1,350,000 shares at AUD \$0.40 per Share. The Convertible Notes are convertible at the option of the Convertible Note Holder at any time prior to maturity. Pursuant to Resolution 4, Shareholder approval is sought for the purposes of Listing Rule 7.1 and for all other purposes for the issue of up to 1,350,000 Shares, at an issue price of AUD\$0.40 per Share.

Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

The effect of Resolution 4 will be to allow the Company to issue the Shares upon conversion of the Convertible Notes during the period of 3 months after the Meeting (or a longer period, if allowed by ASX), without using the Company's 15% annual placement capacity.

Technical information required by ASX Listing Rule 7.3

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to the proposed issue:

- a. the maximum number of Shares to be issued is 1,350,000

Resolution 5: Approval for the issue of up to 450,000 fully paid ordinary shares to Mr Paul Barnes

In July 2014, the Company issued GBP 100,000 in Convertible Notes to Mr Paul Barnes as outlined in the Half Year report reported to the ASX on 29 August 2014. The proceeds of issue of Convertible Notes were used to increase working capital. Subject to the approval at the AGM, the Convertible Notes are convertible into 450,000 fully paid ordinary shares. Once approval has been granted, the Convertible Notes are convertible at the option of Mr Paul Barnes at any time prior to maturity on 31 July 2015.

Pursuant to Resolution 5, Shareholder approval is sought for the purposes of Listing Rule 10.11 and for all other purposes for the issue of 450,000 Shares, to Mr Paul Barnes.

Why is Shareholder approval required?

Listing Rule 10.11 provides that a company must not issue or agree to issue equity securities to a related party of the company without first obtaining Shareholder approval. As a Director, for the purposes of Listing Rule 10.11, Mr Paul Barnes is a related party of the Company.

Other information and Directors' recommendation

For purposes of Listing Rule 10.13 the following information is provided:

- a. number of Shares to be issued to Mr Paul Barnes: 450,000 Shares:
- b. the date of issue: no later than one month after the date of the Meeting.
- c. the issue price will be AUD\$0.40 per Share, the Company will not receive any funds upon issue of the Shares, as the Convertible Note Holders paid their subscription monies at the time of issue of the Convertible Notes; and
- d. terms of issue: the Shares are fully paid ordinary shares and rank equally with all other existing Shares.

If Shareholder approval is given under Listing Rule 10.11, it is not required under Listing Rule 7.1.

The Directors (other than Mr Paul Barnes) recommend you vote in favour of Resolution 5. As Mr Paul Barnes has a personal interest in Resolution 5 he makes no recommendation in relation to it.

Resolution 6: Approval for the issue of up to 450,000 fully paid ordinary shares to Mr Peter Stephens

In July 2014, the Company issued AUD \$180,000 in Convertible Notes to Mr Peter Stephens as outlined in the Half Year report reported to the ASX on 29 August 2014. The proceeds of issue of Convertible Notes were used to increase working capital. Subject to the approval at the AGM, the Convertible Notes are convertible into 450,000 fully paid ordinary shares at AUD \$0.40 per Share. Once approval has been granted, the Convertible Notes are convertible at the option of the convertible note holder at any time prior to maturity on 31 January 2016.

Pursuant to Resolution 6, Shareholder approval is sought for the purposes of Listing Rule 10.11 and for all other purposes for the issue of 450,000 Shares, at an issue price of AUD\$0.40 per Share to Mr Peter Stephens.

Why is Shareholder approval required?

Listing Rule 10.11 provides that a company must not issue or agree to issue equity securities to a related party of the company without first obtaining Shareholder approval. As a Director, for the purposes of Listing Rule 10.11, Mr Peter Stephens is a related party of the Company.



Other information and Directors' recommendation

For purposes of Listing Rule 10.13 the following information is provided:

- a. number of Shares to be issued to Mr Peter Stephens: 450,000 Shares;
- b. the date of issue: no later than one month after the date of the Meeting.
- c. the issue price will be AUD\$0.40 per Share, the Company will not receive any funds upon issue of the Shares, as the Convertible Note Holders paid their subscription monies at the time of issue of the Convertible Notes; and
- d. terms of issue: the Shares are fully paid ordinary shares and rank equally with all other existing Shares.

If Shareholder approval is given under Listing Rule 10.11, it is not required under Listing Rule 7.1.

The Directors (other than Mr Peter Stephens) recommend you vote in favour of Resolution 6. As Mr Peter Stephens has a personal interest in Resolution 6 he makes no recommendation in relation to it.

Resolutions 7 and 8: Treasury shares

The Board is seeking authority to buy back shares in the Company. The overall purpose of the buyback resolution is to provide the Company with flexibility in the conduct of its capital management initiatives, whether through on or off-market share buybacks. There may be circumstances when share purchases may be in the best interests of the Shareholders and therefore authority is sought for the Company or any of its subsidiaries, to purchase up to ten per cent of the issued ordinary share capital of the Company during the period stated below. The Directors will exercise this authority only after careful consideration, taking into account prevailing market conditions, other investment opportunities and the overall financial position of the Company. The authority will expire on the later of 19 June 2016 and the date of the next Annual General Meeting. The maximum price that may be paid for an ordinary share (exclusive of expenses) is 105 per cent of the average middle market quotation for the five business days immediately preceding the purchase and the minimum price that may be paid for an ordinary share (exclusive of expenses) is its nominal value.

Pursuant to the 2006 Act, the Company can hold the shares which have been repurchased itself as treasury shares and resell them for cash, cancel them (either immediately or at a point in the future), or use them for the purposes of its employee share plans. Whenever any shares are held as treasury shares, all dividend and voting rights on these shares are suspended. Any shares purchased under the authority, if approved, would be either held as treasury shares or cancelled.

Resolution 9: Authority to issue up to an additional 10% of issued share capital

Listing Rule 7.1A enables eligible entities to issue Equity Securities (as that term is defined in the Listing Rules) up to 10% of its issued share capital in accordance with the terms set out below (10% Placement Facility). The 10% Placement Facility is in addition to the Company's 15% placement capacity under Listing Rule 7.1.

The Company is now seeking shareholder approval by way of a special resolution to have the ability to issue Equity Securities under the 10% Placement Facility.

General

Listing Rule 7.1A enables eligible entities to issue Equity Securities up to 10% of its issued share capital through placements over a 12 month period after the annual general meeting (10% Placement Facility). The 10% Placement Facility is in addition to the Company's 15% placement capacity under Listing Rule 7.1. An eligible entity for the purposes of Listing Rule 7.1A is an entity that is not included in the S&P/ASX 300 Index and has a market capitalisation of \$300 million or less. The Company is an eligible entity.

The Company is now seeking Shareholder approval by way of a special resolution to have the ability to issue Equity Securities under the 10% Placement Facility. The exact number of



Equity Securities to be issued under the 10% Placement Facility will be determined in accordance with the formula prescribed in Listing Rule 7.1A.2. The Company is currently continuing development activities associated with existing intellectual property developments and is also reviewing additional intellectual property developments. The Company may use the funds raised from the issue of Equity Securities under the 10% Placement Facility on its existing intellectual property developments and/or new intellectual property developments or investments.

Description of Listing Rule 7.1A

(1) Shareholder approval

The ability to issue Equity Securities under the 10% Placement Facility is subject to Shareholder approval by way of a special resolution at an Annual General Meeting.

(2) Equity Securities

Any Equity Securities issued under the 10% Placement Facility must be in the same class as an existing quoted class of Equity Securities of the Company. The Company, as at the date of the Notice, has on issue three classes of Equity Securities: Shares, CDIs and unlisted options.

(3) Formula for calculating 10% Placement Facility

Listing Rule 7.1A.2 provides that eligible entities which have obtained Shareholder approval at an annual general meeting may issue or agree to issue, during the 12 month period after the date of the annual general meeting, a number of Equity Securities calculated in accordance with the following formula:

$$(A \times D) - E$$

A is the number of shares on issue 12 months before the date of issue or agreement:

- plus the number of fully paid shares issued in the 12 months under an exception in Listing Rule 7.2;
- (B) plus the number of partly paid shares that became fully paid in the 12 months;
- (C) plus the number of fully paid shares issued in the 12 months with approval of holders of shares under Listing Rule 7.1 and 7.4. This does not include an issue of fully paid shares under the entity's 15% placement capacity without Shareholder approval:
- (D) less the number of fully paid shares cancelled in the 12 months.

Note that A is has the same meaning in Listing Rule 7.1 when calculating an entity's 15% placement capacity.

D is 10%

E is the number of Equity Securities issued or agreed to be issued under Listing Rule 7.1A.2 in the 12 months before the date of the issue or agreement to issue that are not issued with the approval of Shareholders under Listing Rule 7.1 or 7.4.

(4) Listing Rule 7.1 and Listing Rule 7.1A

The ability of an entity to issue Equity Securities under Listing Rule 7.1A is in addition to the entity's 15% placement capacity under Listing Rule 7.1. At the date of this Notice, the Company has on issue 31,980,784 Shares and therefore has a capacity to issue:

- (i) 4,797,117 Equity Securities under Listing Rule 7.1; and
- (ii) subject to Shareholder approval being obtained under this resolution 10, 3,198,078 Equity Securities under Listing Rule 7.1A.



The actual number of Equity Securities that the Company will have capacity to issue under Listing Rule 7.1A will be calculated at the date of issue of the Equity Securities in accordance with the formula prescribed in Listing Rule 7.1A.2 (refer to section (3) above).

(5) Minimum Issue Price

The issue price of Equity Securities issued under Listing Rule 7.1A must be not less than 75% of the VWAP of Equity Securities in the same class calculated over the 15 Trading Days immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed; or
- (ii) if the Equity Securities are not issued within 5 Trading Days of the date in paragraph (i) above, the date on which the Equity Securities are issued.

(6) 10% Placement Period

Shareholder approval of the 10% Placement Facility under Listing Rule 7.1A is valid from the date of the annual general meeting at which the approval is obtained and expires on the earlier to occur of:

- (i) the date that is 12 months after the date of the annual general meeting at which the approval is obtained; or
- (ii) the date of the approval by Shareholders of a transaction under Listing Rules 11.1.2 (a significant change to the nature or scale of activities) or 11.2 (disposal of main undertaking), or such longer period if allowed by ASX (10% Placement Period).

Listing Rule 7.1A

The effect of Resolution 9 will be to allow the Company to issue the Equity Securities under Listing Rule 7.1A during the 10% Placement Period without using the Company's 15% placement capacity under Listing Rule 7.1. Resolution 9 is a special resolution and therefore requires approval of 75% of the votes cast by Shareholders present and eligible to vote (in person, by proxy, by attorney or, in the case of a corporate Shareholder, by a corporate representative).

Specific information required by Listing Rule 7.3A

Pursuant to and in accordance with Listing Rule 7.3A, information is provided in relation to the approval of the 10% Placement Facility as follows:

- (2) If Resolution 3 is approved by Shareholders and the Company issues Equity Securities under the 10% Placement Facility, the existing Shareholders' voting power in the Company will be diluted as shown in the below table. There is a risk that:
 - (i) the market price for the Company's Equity Securities may be significantly lower on the date of the issue of the Equity Securities than on the date of the Meeting; and

- (3) The Company will only issue and allot the Equity Securities during the 10% Placement Period. The approval under Resolution 9 for the issue of the Equity Securities will cease to be valid in the event that Shareholders approve a transaction under Listing Rule 11.1.2 (a significant change to the nature or scale of activities or Listing Rule 11.2 (disposal of main undertaking).
- (4) The Company may seek to issue the Equity Securities for the following purposes:
 - (i) non-cash consideration for [the acquisition of the new assets and investments. In such circumstances the Company will provide a valuation of the non-cash consideration as required by Listing Rule 7.1A.3; or
 - (ii) cash consideration. In such circumstances, the Company intends to use the funds raised towards activities at its existing projects and/or for acquisition of new assets or investments (including expenses associated with such acquisition) and general working capital.

The Company will comply with the disclosure obligations under Listing Rules 7.1A(4) and 3.10.5A upon issue of any Equity Securities. The Company's allocation policy is dependent on the prevailing market conditions at the time of any proposed issue pursuant to the 10% Placement Facility. The identity of the allottees of Equity Securities will be determined on a case-by-case basis having regard to the factors including but not limited to the following:



- (i) the methods of raising funds that are available to the Company, including but not limited to, a rights issue or other issue in which existing security holders can participate;
- (ii) the effect of the issue of the Equity Securities on the control of the Company;
- (iii) the financial situation and solvency of the Company; and
- (iv) advice from corporate, financial and broking advisers (if applicable).

The allottees under the 10% Placement Facility have not been determined as at the date of this Notice but may include existing substantial Shareholders and/or new Shareholders who are not related parties or associates of a related party of the Company.

- (5) The Company has previously obtained Shareholder approval under Listing Rule 7.1A. In the 12 months preceding the date of this meeting, 416,667 equity securities were issued in the form of convertible notes. None of these convertible notes have been converted into ordinary shares at the date of this notice. If all of these convertible notes had been converted into ordinary shares, then the ordinary shares would represent 1.3% of the ordinary shares on issue 12 months preceding the date of this meeting. Key terms of the convertible notes are as follows:
 - unsecured
 - convertible into ordinary fully paid shares at a conversion price of \$1.20
 - unlisted
 - interest accrues at 90 day bank bill swap rate plus 6% subject to a minimum of 10% per annum. Interest is paid quarterly in arrears.
 - If not converted, the convertible notes were to be repaid on 31 December 2014. Prior to this date, a portion of the convertible notes were repaid and the remainder extended until 31 December 2016 at 8% interest. None of these convertible notes have been converted into ordinary shares.

The convertible notes were issued to sophisticated professional investors. The issue of convertible notes raised AUD\$500,000 which was employed by the company in intellectual property developments and supplementing working capital.

(6) A voting exclusion statement is included in the Notice. At the date of the Notice, the Company has not approached any particular existing Shareholder or security holder or an identifiable class of existing security holder to participate in the issue of the Equity Securities.
