### **Term of the Appointment**

Mr van Kruining has been appointed Chief Executive Officer from 25 May 2015 with no fixed term.

#### Remuneration

The remuneration payable to Mr van Kruining will be:

- 1. A total fixed remuneration of \$250,000 per annum plus superannuation in accordance with statutory requirements.
- 2. A potential Short Term Incentive opportunity of up to a maximum of \$50,000, subject to meeting a Board approved EBIT target of \$1.6M for the financial year 2015/16.

### **Termination**

Either party may terminate the employment relationship on 3 months' written notice.

Mr van Kruining's remuneration package will be reviewed after 6 months thereafter annually at the Board's discretion.
