Results of Extraordinary General Meeting

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act 2001 (Cth), Entellect Limited (**Entellect** or the **Company**) advises shareholders of the results of its Extraordinary General Meeting (**EGM**) held today, 28 May 2015.

All resolutions were passed on a unanimous show of hands; details of the resolutions and the proxies received in respect of each resolution are set out in the attached proxy summary.

Change of Company Name and ASX issuer code

Following shareholder approval of Resolution 1 of the Notice of EGM, the Company's name has changed to **KneoMedia Limited**, effective today. The Company advises that its ASX issuer code will change from 'ESN' to 'KNM'.

The change in the Company's name to KneoMedia Limited reflects and aligns with the Company's core business, more particularly its flagship product KNeoWORLD.

Share Consolidation

In addition, following shareholder approval of Resolution 2 of the Notice of EGM, the Company confirms that a consolidation of its securities will be undertaken in accordance with the terms set out in the Explanatory Statement to Resolution 2 in the Notice of EGM, and the timetable announced to the market on 29 April 2015.
