

PRE-QUOTATION DISCLOSURE

The following information is required to be provided to ASX Limited for release to the market in connection with the official quotation and conditional and deferred settlement trading of the fully paid stapled securities ("**Stapled Securities**") in Gateway Lifestyle Group ("**GTY**"), comprising of one share in Gateway Lifestyle Operations Limited (ABN 63 605 543 698) ("**GLOL**") and one unit in the Residential Parks No.2 Trust (ARSN 605 803 414) ("**RPT2**").

Capitalised terms which have not been otherwise defined in this document have the meaning given to them in the replacement combined prospectus and product disclosure statement lodged with the Australian Securities and Investments Commission on 28 May 2015 ("Offer Document").

Basis of allocation and procedures for determining allocations

Gateway Lifestyle Group has arrangements for the purposes of ASX Operating Rule 3331(b) to facilitate an orderly market in the Gateway Lifestyle Group's securities and in particular to ensure that applicants are able to determine their entitlements for the purposes of conditional and deferred settlement trading by arranging for security information centre toll free lines to meet the reasonably anticipated demand for information about allocations and to handle applicant queries. Conditions for the Conditional Market

- the Proposed Transaction, as described in Sections 12.3 and 12.4 of the Offer Document, has completed;
- the Existing Stapled Securities to be sold by SaleCo having been transferred to SaleCo;
- Gateway Lifestyle Group has issued the Stapled Securities; and
- SaleCo has transferred the Existing Stapled Securities it holds, to successful Applicants under the Offer.

It is expected that all of these conditions will be satisfied on Monday, 15 June 2015.

The Offer Price for each Stapled Security under the Institutional Offer, the Broker Firm Offer, the Priority Offer and the Employee Gift Offer is \$2.00.

- Broker Firm Offer 30,000,000 Stapled Securities;
- Priority Offer 18,641,600 Stapled Securities; and

The total number of Stapled Securities on issue at Completion of the Offer is 249,397,735.
